- ✓ Under no circumstance will this cat/kitten be sold, traded, gifted or transferred to any other party without the written consent of the breeder nor will the cat/kitten be sold, traded, gifted, leased or given to any animal shelter, research facility, research laboratory, breeding mill, pet store, or other commercial or non commercial enterprise. In the event that the purchaser can no longer keep this cat/kitten, the Seller will be contacted immediately. Arrangements to bring the cat/kitten back to Ragdoll Angels will be made if another acceptable home cannot be located.
- ✓ This cat/kitten is being sold with the understanding that it will be an indoor pet ONLY! Seller will automatically void health/genetic guarantee if the kitten is declawed or allowed to roam outdoors. A scratching post, scratch post training and regular nail trimming MUST be provided for the cat/kitten. In the very rare event that it becomes absolutely necessary to declaw your Ragdoll, the Seller will be consulted about alternatives prior to surgery. If declawed without written permission from Seller prior to surgery this contract automatically becomes null and void.
- ✓ Seller stresses the importance of providing responsible care for the animal, including proper nutrition, flea control and veterinarian care when needed. The Buyer agrees to provide the cat/kitten with a clean, pleasant environment conducive to good health, with adequate space for exercise. At least one litter box will be provided for each cat in the household and will be cleaned daily. The Buyer will provided yearly check up's and vaccines. Any significant health condition during the cat/kitten's life time should be reported to the Seller immediately.
- ✓ The cat/kitten is judged to be in good health at the time of sale. If the cat/kitten should become ill within 7 days of purchase, the buyer agrees to contact the Seller immediately (before rushing to the vet). This Ragdoll is guaranteed healthy for 48 hours against upper respiratory infections, worms and fungus. The seller certifies that all the cats in our breeding program are negative for FELV (Feline Leukemia) and FIV (Feline Aids). We strongly suggest that you DO NOT have your cat/kitten vaccinated for this, as the mortality is very high in kittens. If the Buyer chooses to inoculate for feline infectious peritonitis (FIP) the warranty is immediately void. In addition the Seller will not warranty the cat/kitten against any adverse reactions to future vaccinations. The Seller recommends that you have your Ragdoll checked by your veterinarian with 72 hours of arrival at your home to ensure its health. If the veterinarian finds any physical problems that make the cat/kitten a poor health risk, the veterinarian should write a short note on his/her letterhead stationery, explaining his/her finds. The Seller will decide if the cat/kitten will be returned in exchange for a refund or a replacement cat/kitten. Any transportation cost will be the sole responsibility of the Buyer.

- ✓ **IMPORTANT NOTE:** Do not allow your cat/kitten to be given “Keraset/Ace” anesthesia combo, ever for any reason. Health guarantee is void if the cat/kitten has had this combination. We strongly suggest “Isofluramine” as the anesthetic of choice. Please make sure your vet is aware of this request in advance to any procedure.
- ✓ If the kitten described above dies within TWO years from the date of birth due to any congenital or hereditary defect, the Seller will replace the cat/kitten with another cat/kitten of similar or superior quality. To determine if the cat/kitten's death was in fact caused by a congenital or hereditary defect, the Seller must receive proof of the defect in the form of a complete autopsy report, completed and signed by a licensed veterinarian and performed at the Buyers expense.
- ✓ The Seller will provide the Buyer with a complete record of all vaccinations, surgeries and de-wormings. We strongly recommend that you do not give Rabies or Leukemia vaccinations. The only approved vaccines are 3 in 1 combo in Killed or Modified Live Virus of Rhinotrachetis, Panleukopenia and Calicivirus. If it becomes absolutely necessary to give Rabies please administer 3-4 weeks after final booster. Giving all vaccines at the same time or in conjunction with any surgery will make the health guarantee null and void.
- ✓ The Seller reserves the right to terminate sale if the cat/kitten's placement does not seem beneficial to the cat/kitten or cattery. Should this be the case a full refund will be provided immediately.
- ✓ Buyer agrees to remain in contact with Seller and provide them with updates and lots of pictures. ☺

VACCINATIONS:

This cat has been given an adult yearly booster/ this kitten has been given **Two** sets of kitten boosters. Our cats/kittens are vaccinated with Fort Dodge Fel-o-vax PCT KILLED, all dates are provided in charts. Next scheduled vaccination is due on : _____ - at age: **1 year 3 months.**

We recommend vaccinating preferably with killed or 3 way modified live viruses of Rhinotrachetis, Panleukopenia and Calicivirus.

- The Seller will not be held liable for any veterinary, health care costs or medications occurring while the cat is in possession of the Buyer, except as provided for by the above limited warranty.
- If legal proceedings become necessary, the Buyer agrees that all legal and/or court procedures must take place with Los Angeles County, California USA.
- The Sellers maximum liability to the Buyer for any and all losses, claims, damages or liabilities of any kind shall be limited to the amount paid by the Buyer to the Seller for this cat/kitten under this contract.
- The Buyer certifies that he/she is 18 years of age or older.

By signing below, the parties of the Buyer and Seller indicate that they have read and agree with all the provisions of the above and agree to abide by the terms of this contract.
